## ALIMENTARY CERTIFICATION

THE HOSE NAMED **ESPIROCRISTAL FOOD** IS MADE BY EXTRUSION OF VYNILIC MATERIALS. IT IS EXEMPT FROM HEAVY METALS, NON TOXIC, AND SUITABLE TO BE IN CONTACT WITH FOOD, AS LONG AS THEY ARE NOT FATTY FOODS, AS WELL AS ALCOHOL UP TO 20° (20%)

THIS PRODUCT FULFILS THE GOOD MANUFACTURING PRACTICES FOR MATERIAL INTENDED TO BE IN CONTACT WITH FOOD STATED IN THE REGULATION Nº 2023/2006 OF THE EUROPEAN COMMISSION. MOREOVER THE MATERIALS USED IN ITS FABRICATION FULFIL THE REGULATION Nº 1935/2004 OF THE EUROPEAN PARLIAMENT AND THE COUNCIL REGARDING MATERIAL AND OBJECTS INTENDED TO BE IN CONTACT WITH FOOD. ALL THE COMPONENTS USED ARE ALSO LISTED IN THE POSITIVE LIST OF PRODUCT ADMITTED TO BE IN CONTACT WITH FOOD, STATED IN THE REGULATION Nº 10/2011 OF THE EUROPEAN COMMISSION.

THE RAW MATERIAL HAS BEEN SUBMITTED TO GLOBAL MIGRATION TEST BY THE INDEPENDENT LABORATORY APPLUS, FOLLOWING THE QUALITY NORM EN 1186, USING THE ALIMENTARY SIMULANTS A (ETHANOL 10%), B (ACETIC ACID 3%) AND C (ETHANOL 20%), FULFILLING THE LIMITS STATED ON THE 10/2011 REGULATION.

IN THE FORMULATION IS USED AS PLASTICISER DI-ISONONYL PHTHALATE (DINP) AND SPECIFIC MIGRATION TEST HAS BEEN CONDUCTED FOR THIS CHEMICAL PRODUCT WITH THE SAME SIMULANTS, FULFILLING ALSO THE LIMITS STATED ON THE 20/2011 REGULATION

THEREFORE, ACCORDING THE DIRECTIVE 85/572/CEE, THIS PRODUCT IS ONLY RESTRICTED FOR USING WITH ALIMENTS WITH FAT CONTENT AND ALCOHOLIC LIQUIDS WITH A GRADUATION SUPERIOR TO 20° (20%).
